September 1 of the same year brought another exciting development when Andrew was appointed as a partner. At the end of 2001, we became Mosdell, Pama & Cox. Since then, there have been significant further changes, with Perino Pama relocating to the Plettenberg Bay office. Clifford Mosdell retired as a director on 28 February 2013. Celeste van Wyk was appointed as a director on 1 March 2021. Willy Hosana

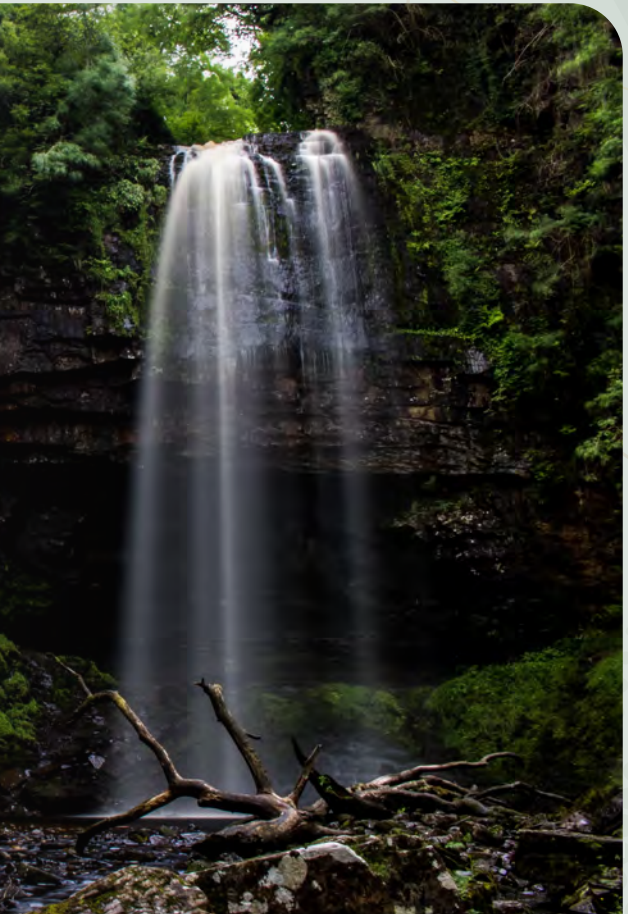
